



## 2022 GCA COMMITTEE MEMBER NOMINATION FORM

1. Each chapter is required to submit their recommendations to the Nominating Committee for consideration of potential placement in committees and Region VP positions. This form is required to be submitted by October 1, 2022 to ensure all recommendations are considered. Applications should be sent via USPS mail or e-mail to [taylor.pearce@gabeef.org](mailto:taylor.pearce@gabeef.org)
2. According to the GCA Bylaws, Article 9, Section 5: Committee and Subcommittee Member Selection, each county or area chapter shall put forth names of one nominee per committee for consideration by the Nominating Subcommittee. Nominees shall be grouped according to their neighboring regions: Regions 1-3, Regions 4-6, Regions 7-9, Regions 10-12, and Regions 13-15. The Nominating Subcommittee shall select one representative from each regional area to serve and carry the vote for that area. If a chapter does not submit any names, the Nominating Subcommittee shall select a candidate from that area to serve at large. The Selections shall require the approval of the Governance Committee, Executive Committee, and Board of Directors. A nominee shall serve for no more than three consecutive terms on any one committee. The Chair and Vice-Chair for each committee shall be appointed by the GCA President with the approval of the Board of Directors.

  - a. Region 2 Vice President (Appalachian, Blue Ridge Mountain, Lumpkin, North Georgia)
  - b. Region 5 Vice President (Barrow, Clarke-Oconee, Henry, Morgan, Piedmont, Walton)
  - c. Region 8 Vice President (Baldwin-Jones-Putnam, Central Georgia, Mid Georgia, Taylor)
  - d. Region 11 Vice President (Ben Hill-Irwin, Heartland, Laurens, Macon, Ocmulgee, Three Rivers, Turner)
  - e. Region 14 Vice President (Colquitt, South GA, South GA Black Cattlemen's, Thomas, Tift, Wiregrass, Worth)
